3. **WAIVER OF LIABILITY:** I acknowledge and agree that the **SCA is not responsible** in any way for any loss or damage sustained by me, including loss or damage caused by injury to my person or property or by my death howsoever caused and **notwithstanding that the same may have been caused or contributed to by the negligence or gross negligence of the SCA.** I release, waive and forever discharge the SCA from all claims, demands, damages, costs, expenses, actions, causes of action, whether in law or equity, in respect of death, injury, loss or damage to my person or property, howsoever caused, arising by reason of my participation/attendance at the Event, or in any activities associated with this Event, **notwithstanding that the same may have been caused or contributed to by the negligence or gross negligence of the SCA.**
4. **INDEMNIFICATION:** I agree to indemnify the SCA from any claims or demands made against the SCA, or any other liability incurred by the SCA, arising as a result of, or in any way connected with, my actions, participation and/or attendance at this Event.
